The following information should accompany the application:

- (a) two (2) personal references indicating the applicant's ability to purchase the land and to carry out the proposed development or improvement;
- (b) two (2) character references;
- (c) one (1) financial reference (preferably from your current banking institution);
- (d) one (1) Police Certificate;
- (e) one (1) Identification document (preferably a colored passport sized photograph);
- (f) four (4) consecutive newspaper advertisements relating to the particulars of the property;
- (g) a letter sized version (8½ x 11) of the cadastral survey map reflecting the acreage and name(s) of the adjacent landowners of the property. (survey map should be obtained from a local surveyor).
- (h) copy of belonger's birth certificate or naturalization certificate;
- (i) copy of current Trade Licence, if self-employed.

The above-mentioned documents must be submitted as **ORIGINALS** and not **XEROGRAPHED, except for the newspaper advertisements**. All written references must reflect a current date and be addressed to the Ministry of Natural Resources and Labour.
